### **Step 6. Obtaining Vital Records**

- Once you have identified your ancestors through census records, family trees or other sources, the next step is to obtain or locate copies of their vital records such as birth certificates or baptism records, marriage records, death or burial records and obituary notices. These records can provide important information about your ancestors and help you build a comprehensive family tree.
- There are several ways to obtain or locate copies of vital records:
- 1. Online databases: Many vital records are now available online through government websites, genealogy websites or other databases. Examples include Ancestry.com, FamilySearch.org, VitalChek.com, and more.
- 2. Government offices: Vital records can be obtained from government offices such as the Department of Health or Vital Statistics in the state or county where the event occurred.
- 3. Local archives and libraries: Local archives and libraries may have collections of vital records, especially for the local area. You can contact them or visit in person to access these records.
- 4. Family members: Family members may have copies of vital records in their possession, especially for more recent generations.
- Genealogical societies: Genealogical societies can be a valuable resource for obtaining or locating vital records. They often have collections of records or can provide guidance on where to find them.
- 6. Funeral homes: Funeral homes may have copies of death or burial records, as well as obituary notices, that they can provide to family members.
- It is important to note that not all vital records are available online or through government offices. Some may be restricted due to privacy laws or simply not available

for certain time periods. In these cases, alternative sources such as family members or genealogical societies may be more helpful.

 When obtaining or locating vital records, it is important to keep track of the information you find. Record the date, source and any other relevant details so you can refer back to it later. Also, be prepared to pay fees for obtaining copies of vital records from government offices or online databases.
